# **OUR SAVIOUR LUTHERAN CHURCH (OSL) TRANSITION**

Hello from your newly elected Council. We **thank you** all for participating in the September 22 congregational meeting – either in person, via Zoom, or at home praying for our congregation. We have several important pieces of information for you:

- "Interim and Transition Activities" resulting from Pastor Joel's resignation and his call to Holy Trinity Lutheran Church in Lancaster. We thank Pastor Joel for his tenure with us. In Pastor's words, "the season is changing and it's time." Indeed, the season is changing and with God's grace, our congregation will move from autumn to spring.
- 2. 2024-2025 Council Members
- 3. Communications (aka "RUMOR CONTROL")

#### "Interim/Transition Activities"

SUNDAY SERVICES will continue. We will have "supply" pastors until Synod assists us with obtaining an "interim" pastor. The weekly bulletin will contain information about the "pastor on call" and how to contact the "pastor on call" for your pastoral needs. You can also call the church office at 717-545-9992 for assistance.

We ask that all OSL COMMITTEES and activities' groups **continue** their wonderful work on behalf of the congregation. We thank you for your time and talents and commitment.

**REFORMATION SUNDAY, OCTOBER 27,** matters. In 1517, Martin Luther posted a list of 95 Theses that went "viral". We continue to celebrate Reformation Sunday in 2024 as a time to "tell our story" of faith and have a "chance to remember" that "God loved us first" and "continues to shower us with grace and mercy", and prods us to "do better." These words are very helpful as we "transition."

SYNOD's representative, Rev. Beth Martini, Assistant to the Bishop, will be meeting with Council on October 10 to discuss OSL's options and Synod requirements for next steps. We will keep you informed of our discussions and share information through temple talks, the weekly bulletins, monthly newsletter, and other forms of communication.

Concurrent with our discussions with Synod, there is an additional effort among some of the churches within the Synod's Cumberland Conference to have conversations about "SHARING PASTORAL RESOURCES". The first meeting took place on June 8 – some of you may have attended.

A new invitation from Pastor Trout, Secretary of the Synod's Cumberland Conference, was sent from our church office via email on September 18, 2024 regarding the second conversation to be held on **SATURDAY**, **OCTOBER 12, 9:00 a.m. to 11:30 a.m. at OUR SAVIOUR**. The meeting is hosted by Gwenn Trout, Pastor Zion & St. Paul's Enola, who conducted the June 8 meeting. The purpose is to have conversations about "how congregations large and small (and everyone in between) can work together in having pastoral care coverage."

PLEASE give us your input, questions, concerns, suggestions. AND if the Spirit moves you, volunteer your time (a lot or a little) to one of our Committees.

#### **Covenant of Closure**



# Policy for a Covenant of Closure for Former Ministers and their Calling Communities

We believe that the Holy Spirit is acting when a minister of Word and Sacrament or minister of Word and Service is called to serve God's people and also that the Holy Spirit is acting when it is time for that minister to accept another call, including the call into retirement.

A healthy relationship between a minister and God's people is often mutually enriching and joyous. While serving a congregation, a minister is deeply involved in the lives of God's people, and it is appropriate that strong bonds of trust, friendship, commitment, and interdependence develop.

However, when the Holy Spirit leads the minister to a new call or into retirement, those relationships, however strong, must change for the future health of both the congregation and the minister. For the congregation to move forward, its members need to accept fully the authority and guidance of succeeding ministers, both interim and called, even as they cherish the memory and leadership of the former minister. For former ministers to live into their new lives of service or retirement, they need to surrender pastoral and ministerial authority and sever pastoral and ministerial ties with their former congregations and their people.

The following expectations will help clarify the new relationship between former ministers, congregations, and the people they formerly served:

#### Congregations and Members:

- -Will not reach out to former ministers for professional care in times of emotional, spiritual, or physical need, but rather will seek such care exclusively from their current minister.
- -Will not invite or approach former ministers to perform or participate in pastoral and ministerial acts, such as weddings, funerals, baptisms, home communions, etc., but rather will approach exclusively the current minister.
- -Will not seek the counsel of former ministers (or their family members) on matters relating to the congregation, including its worship life, finance, administration, leadership, or other issues. Members will avoid talking with former ministers (and family members) about congregation matters.
- -Will not expect former ministers (or their family members) to retain membership in the congregation, to attend worship, or to participate in activities or events in the life of the congregation.
- -Will speak positively of former ministers (and their family members). As Martin Luther explains in the *Small Catechism*, the Eighth Commandment compels us to do so: "We are to fear and love God, so that we do not tell lies about our neighbors, betray, or slander them, or destroy their reputations. Instead, we are to come to their defense, speak well of them and interpret everything they do in the best possible light."
- -Will, in continuing personal relationships, regard former ministers as friends only. Although it is proper to address any ordained minister with an appropriate title (such as Pastor, Deacon, or Sister), in light of the new relationship, members are wise to remember that the former minister no longer serves them or their community.

## Covenant continues

#### Former Ministers:

- -Will politely but firmly refuse requests to provide ministerial care to former congregation members, instead referring them to the current minister. For the health of the congregation and the integrity of the ministry of the current minister, this rule will be without exception.
- -Will politely but firmly refuse all requests to perform or participate in pastoral and ministerial acts, such as weddings, funerals, baptisms, home communions, etc., instead referring them to the current minister. (Former ministers will respond to all such requests with an unequivocal "no" and not suggest that members ask the current minister if it is okay. Such a request puts the current minister in a very difficult position, creates an unhealthy triangle, and can set a dangerous precedent.)
- -Will decline to comment on matters relating to the former congregation, including worship life, finance, administration, interpersonal relationships, conflicts, or politics. Former ministers will counsel their family members similarly to decline. It is wise for former ministers to discourage members even from talking with them about congregation affairs.
- -Will move the official membership for themselves and all family members to another congregation. Former ministers and family members will refrain from attending worship or participating in regular events and activities in the life of the congregation.
- -Will speak well of the former congregation, its leaders, and its members. As Martin Luther explains in the *Small Catechism*, the Eighth Commandment instructs us to do so: "We are to fear and love God, so that we do not tell lies about our neighbors, betray, or slander them, or destroy their reputations. Instead, we are to come to their defense, speak well of them, and interpret everything they do in the best possible light."
- -Will, in continuing personal relationships, regard members of the former congregation as friends only. In light of this new relationship, former ministers will encourage former congregation members to address them by their given name. When they are addressed with the honorific title of "Pastor, Deacon, or Sister," ministers will remind, as appropriate, former members that they no longer serve as *their* minister.

#### Covenant of Closure

In order to promote a healthy closure to the ministry tenure of our departing minister of Word and Sacrament or minister of Word and Service and a healthy beginning to the tenure of successor ministers, we the undersigned agree to do our best to abide by the conditions of this covenant. We will encourage others in our congregation and our families to do the same by making this covenant a public and living document.

Evangelical Lutheran Church of Our Saviour Minutes of the Regular Council Meeting Wednesday, July 10, 2024

**Members Present:** Pastor Joel Petruschke, Antonetta Fleming, President, Brad Neil, Vice-President, Jim Lubrecht, Treasurer, Jeanette Logan, Secretary, Steve Barron and Penny Zimmerman.

Member Absent: Joel Hains

At 6:10 pm Pastor Joel opened the meeting with a word of prayer.

Pastor Joel made a motion to accept the Council Meeting Minutes from June 12, 2024. The motion was seconded by Brad Neil. The motion carried.

**Treasurer's Report:** Jim reviewed the Budget Performance noting the Pastoral Mission brought in \$19,283.38. He reviewed the Previous Year Comparison January 2024 through June 2024 as well as Our Saviour's Financial Report noting the Memorial Fund Money Market saw an increase of \$229.60 from May 30, 2024, of \$84,591.86 to \$84,821.45 as of June 30, 2024. As of June 30, 2024, we have a deficit of \$2,565.03.

Child Protection Policy - no report

Fund Raising - no report

**Mutual Ministry** - no report. It was discussed that Brad and Deb's terms are up which leaves only Nedda remaining. Three additional members are needed for the committee. Pastor Joel will put this need in the bulletin to try to get additional members.

Scholarship BOT - no report. A meeting is scheduled for September 9, 2024.

Social Ministry - Report submitted and reviewed by Council.

Stewardship - not an active committee

Welcome - no report

Worship and Music - no report

Finance - Jim reported that the next Finance Meeting will be held on August 26, 2024, at 6: 30 pm.

Pastor's Report - Pastor Joel reviewed his report with Council.

**Building/Property -** Brad informed Council that he cannot find a company to repair the light in the parking lot. A lift is needed to make the repairs. The estimates that he has received have been very expensive. He will continue to work on this.

#### **Old Business:**

IT Committee: This is currently on hold.

**Building/Property evaluation committee:** This is currently on hold.

**Update on Membership Role ad-hoc committee:** Jim reported that the membership role update has been completed. Copies of this role were given to Council members and they were asked for any corrections. It was noted that a few membership dates were incorrect and will need to be updated.

**Germanfest fundraiser:** The need for additional volunteers is still a concern. Detailed job descriptions and specific time slots have been included on sign up sheets available in the Narthex. Pastor Joel will continue to make a plea for volunteers during weekly service announcements.

St. Stephen's update: Pastor Joel informed Council that they are still in need of an Interim Pastor.

**Pastor's vacation:** Pastor Joel reminded Council that he will be on vacation July 27th to August 3<sup>rd</sup> and August 5<sup>th</sup> to August 10<sup>th</sup>. He has arranged for supply pastors and Pastor Richard Eckert will provide coverage for pastoral emergencies.

#### **New Business:**

- Announcements of new positions open in church Council and Committees: Discussion ensued pertaining to the need for these volunteers. Steve, Penny and Jeanette will need to be re-elected to council at the September Congregational Meeting. September 22, 2024 is the date for the Congregational Meeting with September 29<sup>th</sup> being the back-up date.
- **Members having issues hearing readers and Pastor**: Jeanette spoke with Herb. This is not an issue with microphones or the sound system. If the person reading does not have the microphone pointed close to their mouth, there will be an issue for those in the back of the Sanctuary to hear them.

Visioning Meeting: The next meeting has been scheduled for August 20th.

**St. Stephen's is having difficulty getting a consistent Pastor for Sundays**: Pastor Joel proposed that he could do Sunday Services for them until the end of the year. This would not be on a contract basis and he would be doing this on his own free time. He would not be going to St. Stephen's during the week.

August Council Meeting: There will not be a meeting in August.

At 8: 15 pm Pastor Joel made a motion to adjourn the meeting. Penny seconded the motion. The motion carried.

The next Council Meeting will be held on Wednesday, September 11<sup>th</sup> at 6:00 pm.
