April finds us at the climax of our Lenten journey. On April 6<sup>th</sup>, we will welcome Rev. Dr. Angela Zimman to lead our worship. Dr. Zimman serves as the Vice President for Institutional Advancement at Wilson College in Chambersburg. She has previously served in a similar role at Gettysburg Seminary where she also taught preaching classes.

On that day, I will be on way to Asheville, NC to participate in a week of home repairs for those people who had serious damage to their homes from last year's hurricanes. I will be joined by members of Lutheran congregations in the Lancaster area. This will be their 25th Mission Trip and I have been honored to have joined with them in the past.

April 13<sup>th</sup> will be Palm/Passion Sunday. On this day we begin our worship by joining the crowds who were waving leaves of palm and shouting Hosanna as Jesus enters the city of Jerusalem and his journey to the cross. Our worship mood changes during the service as we read the Passion According to Luke and remember the events of Holy Week. During Holy Week we will have worship on Maundy Thursday at 7:00 pm and Good Friday at 7:00 pm.

Lent reaches its climax with Holy Week. Holy Week means accompanying Christ on his final journey, bearing our own crosses. Jesus went to Jerusalem to announce good news to the people of that city. He put before the people a choice. Will you be my disciple, or will you be my executioner? That choice has come to us as well. The cross is a source of life for us. Sorrowful, yes. Horrible, yes. But life giving, by the power of God's love.

April 20<sup>th</sup>, we come together for the great celebration of Easter, the Resurrection of our Lord with worship at our regular time of 9:00 am. Easter is the heart of our Chrisitan faith. It is a day of joyous thanksgiving for what God is doing for us and through us. The somberness of Holy week is shattered by the cry, "Alleluia, Christ is Risen!." The day of easter begins a fifty day journey of celebrating hope in the power of the risen Christ to bring us new life.

Theologian Henri Nouwen wrote "The resurrection of Jesus was a hidden event. Jesus didn't rise from the grave to baffle his opponents, to make a victory statement, or to prove to those who crucified him that he was right after all. Jesus rose as a sign to those who loved him and followed him that God's divine love is stronger than death." That is the hope we share, the good news that brings shouts of joyous Alleluias.

## Finance Committee

Hi, I am your Treasurer Jim Lubrecht and I want to write a few words about Our Saviour's Finance committee. This committee was intended to help Church council prepare a budget and help develop procedures for efficient control of revenues and expenses for our church. The committee lay dormant for many years with no meetings or members but about 6 years ago it was revived. Since then, the committee has revised the Treasurer Manual which I use for myself and for anyone else's use to see what I am supposed to be doing for the Church finances. A copy of the Treasurer Manual i in the Church office. The committee has also reorganized budget line items to better reflect and clarify our financial picture. Most importantly the committee is doing a better job of developing a useful Our Saviour yearly budget.

The committee consists of all members of Church Council and anyone else from the congregation that has important input to what we do. We do not meet regularly (monthly) but meet when I think an important finance issue needs to be addressed.

Evangelical Lutheran Church of Our Saviour Minutes of the Regular Council Meeting Tuesday, February 11, 2025

Attendees: President Brad Neil, Secretary Deb Flage, Treasurer Jim Lubrecht, Sandy Moritz, Jeanette Logan,

Penny Zimmerman and Pastor Frank Terhune.

Absent: Steve Barron, Vice-President Carol Ranck, Joel Hains

Call to Order at 6:08 p.m. by President Brad Neil. Opening prayer offered by Pastor Frank.

Brad made a motion to approve the Council meeting minutes of January 14, 2025 as amended. Sandy seconded the motion. The motion carried.

Treasurer's Report – Jim noted that the January 2025 current fund envelope giving is \$1,800 less than January 2024. The Treasurer's Report is filed for audit. Sandy mentioned that she has offered to help John Zimmerman on the Audit Committee.

Secretary Report/Correspondence - None to report.

#### **Church Committee Reports:**

Christian Education - Bible Study has started

Child Protection Policy – no report

Fund Raising – egg making has started. Egg making teams are working on Thursdays and Sundays.

Mutual Ministry – no report

Property – Brad asked for the Council's thoughts on allowing building rentals during egg making season. Jeanette noted that the movable walls can be used to partition off the kitchen. This will be done for the March 1 meeting that Pastor Gwenn Trout is hosting at OSL for churches interested in talking about possibly sharing pastoral resources. Council suggested that rental requests during egg making season should be considered on a case-by-case basis, including rental requests from church members.

Scholarship BOT – Jim noted that Max Reilly and Savannah Beachtel will forfeit their accrued money if they do not go on to higher education before September 2025.

Social Ministry – no report

Stewardship - not an active committee

Welcome – no report

Worship and Music – no report

Finance – Jim mentioned that he will schedule a Finance Committee meeting in March.

Pastor's Report – Pastor Frank asked about having an Ash Wednesday service at OSL. Zion Dauphin has invited OSL members to attend their soup supper and service on Ash Wednesday. While we appreciate their invitation, Council and Pastor Frank decided to have Ash Wednesday service here at OSL. Pastor Frank noted

that Mitchell is available to play the organ that night. He also stated that there will be a Maundy Thursday and Good Friday service at OSL, both at 7 PM. Pastor Frank shared that he has filled in some of the generic items on the Mission Site Profile for OSL to help give our Task Force members a head start on the document. The Task Force meets again at OSL on Wednesday, February 19, 2025.

#### **OLD BUSINESS**

Committee highlight for March newsletter article – Brad noted that Nadine Martin is creating an article about the Welcome Committee.

Follow-up from Congregational meeting – Quorum question – Carol researched a question about having a quorum throughout the Congregational meeting or just at the beginning of the meeting. The quorum must be maintained throughout the meeting especially if voting is involved. Sandy asked how our quorum was determined. The quorum of 30 members was a flat number chosen, not a percentage of members. There was conversation among Council about how to determine an appropriate quorum number for our congregation. This issue may need more discussion. Penny mentioned she thought there would be more questions about sharing pastoral resources during the Congregational meeting. Sandy suggested putting an article in the newsletter about the Task Force and the work being done between OSL and Zion Dauphin.

Thriving Together Grant update - Pastor Frank, Otis and Nadine Martin are on the committee for the Thriving Together Grant. They met with the Susquehanna Township School District to see how a mini-grant of \$1,000 might be used by the district. The grant could supply a classroom with a library containing books about racial justice. The proposal for the grant is due by the end of February and the grant will be announced in March. In addition to funding a classroom library, it was mentioned that OSL could possibly connect with students by reading to them.

Executive Committee meeting with Mitchell – The Executive Committee met with Mitchell on February 5, 2025 to discuss his new contract and provide feedback to him. It was a very productive meeting and feedback was exchanged by both sides. It was requested of Mitchell to arrive 10 minutes earlier before Sunday service and play music during that time. Members had mentioned that they would appreciate having music during that time while they are preparing for worship. Mitchell agreed to do that. Mitchell's 2025 contract with OSL will be available for signature on Sunday (February 16, 2025).

#### **NEW BUSINESS**

Council President as BOT member – Brad noted that as Council President he is a member of the BOT committee. Including him, there will be 3 members from his family on that committee. He feels that is too many from one family and could pose issues. He will step down from the BOT and Vice-President Carol Ranck will take his place.

Pastor email – Brad noted we should use Pastor Frank's church email to communicate with him. There was some concern about Pastor Frank not receiving emails regarding church activities.

Lent church calendar – As noted above, there will be services at OSL for Ash Wednesday, Maundy Thursday and Good Friday this year.

Completed pastoral priorities survey results from the congregation – Pastor Frank stated that the top 3 priorities received from the survey are 1) Preaching, 2) Pastoral Care and 3) Christian Education (in that order). This will be helpful to the OSL Task Force members as they work on sharing pastoral resources.

Upcoming meeting with Zion – the next Task Force meeting with Zion is February 19, 2025 at 6:30 p.m. It will be held at OSL.

Directory update – Pastor Frank mentioned that he has a copy of the church directory but wasn't sure how up-to-date the information was in it. He will ask the Church Secretary to put some copies of the directory in the Narthex so members can review their information and update it as needed.

Sandy made a motion to adjourn the meeting and Brad seconded the motion. The motion carried and the meeting was adjourned at 7:15 p.m.
