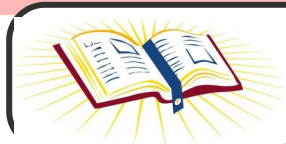

### **Evangelical Lutheran Church of Our Saviour Minutes of the Regular Council Meeting Wednesday, November 8, 2023**

**Members Present:** Pastor Joel Petruschke, Antonetta Fleming, President, Brad Neil, Vice-President, Jim Lubrecht, Treasurer, Jeanette Logan, Secretary, Steve Barron and Penny Zimmerman.

**Members Absent:** Joel Haines

At 6:10 pm the meeting opened with a word of prayer by Pastor Joel.

Pastor Joel made a motion to accept the minutes, as edited from the October 11, 2023 Regular Council Meeting. Penny seconded the motion and the motion carried.

Pastor Joel recalled his motion to approve the minutes from October 11, 2023. Anneke asked if there were any additions or corrections to these minutes. Brad mentioned that Penny has agreed to be the back up to take Council Meeting Minutes in the event Jeanette is unable to attend a meeting. Brad also noted that there was agreement from Council members that the recorded minutes from the audio recorder be erased once the minutes from each meeting have been documented and typed. These two points were not included in the October 11, 2023 minutes.

Pastor Joel made a motion to approve the minutes as edited. Brad seconded the motion and the motion carried.

**Treasurer's Report:** Jim reviewed the Financial Report with Council. He informed Council that we had a surplus in October of \$1,453.31 due to an extra Sunday in the month of October.

**Deficit Analysis Sheet** was reviewed with Council.

**Lutheran Camping Corporation** has sent another letter to the church asking for our donation. Pastor Joel will make an announcement in church informing members that if they wish to donate to Lutheran Camping Corporation they may do so using the envelopes in the pews. Members should designate their donation as, "Lutheran Camping Corporation."

**Budget 2024:** The **Tasking Line** will be added to the 2024 Budget under the Income Column. If we have a balanced budget then we need to have an amount of \$41,955 in revenue brought in.

**Secretary's Report:** Jeanette sent a thank you note to Pam Day for her donation of the grill. Jeanette will make an announcement at church on Sunday thanking everyone for their help with baking items, making soup and selling items on the day of the Election. Discussion ensued about leftover soup from that day. It was decided that we will freeze the leftover soup and inform the people who made these soups that they can retrieve them from the freezer if they desire. If not, Pastor Joel can use the soups to take to shut-ins.

**Fund Raising:** No Report.

**Mutual Ministry:** No Report.



**Property:** Brad informed Council that the **sink has been fixed in the kitchen**. Bernie, Brad and Jim Simmons worked diligently on Sunday to make the repair and it finally appears to be working. Brad mentioned that he will ask Jim Simmons if he would be willing to be a part of the Property Committee. Steve Barron is also on this committee. **All of the indoor lights in the church have been fixed. The far light in the parking lot is still not working properly.** Brad continues to work on this. Jeanette informed Brad that **Herb has set the timer for the parking lot lights for 5:15 pm since it now gets darker much earlier. The fridge in the kitchen needs a new battery.** He is researching the replacement of the battery. Penny mentioned that she spoke with Nadine Martin who informed her that **the mice are still an issue in the kitchen pantry.** Even though we very recently cleaned all of the mice droppings up and scrubbed all of the racks in the pantry, it appears that they are now leaving droppings on top of the plastic containers that we used to hold the items. **Orkin pest control is scheduled for a visit and Pastor Joel will ask them to put traps in the kitchen and also in the shed** since the mice have made a home in the shed as well. Discussion about the lights under the front door to the Narthex. It is believed that those lights are motion lights for security purposes and do not stay on to light that area. Brad contacted a place about the purchase of a shed.

**Scholarship BOT:** No Report.

**Social Ministry:** No Report.

**Stewardship:** Not an active committee.

**Welcome:** The committee met on Monday, November 6, 2023. The Share the Word luncheon will be held this Sunday. Plans are being made for the Spring Banquet in early May. It was noted that Linda, the chairperson for this committee should submit a budget so funds are allocated for the committee.

**Worship and Music:** No Report.

**Finance:** Jim had a Finance Committee Meeting and minutes for this meeting were taken. Council reviewed these minutes and Jim discussed the details of this meeting with Council.

**Pastor's Report:** A Thanksgiving Service will take place on November 19, 2023 because we will not have a church service on Thanksgiving Eve. There will be a baptism of Walker Parson on Sunday. An update on the St. Stephen's arrangement was given by Pastor Joel. He informed Council that they have conversations with two congregations to see if merging would be a possibility. One church is about 10 minutes away from St. Stephen's and the other church is in Carlisle near Dickinson College and they have a full time pastor. This church is checking into getting an associate pastor to help work with the young people at the college. This associate pastor might be able to help out St. Stephen's as part of their duties and responsibilities. St. Stephen's is doing well and they anticipate ending their year in the black. Penny mentioned a meeting that will be taking place on November 26, 2023 at 2:00 pm. It will include youth members of the church, Pastor Joel and Andrea Faber. Pastor Joel provided insight. He mentioned that Andrea Faber has a vision for another service that would be geared more towards the young people of the church and hopefully appeal to other young people in the community. They met with Music and Worship to discuss this vision. John Zimmerman will be a part of the meeting on November 26th as a member of the Visioning Committee as this discussion needs to be a part of the church's visioning. Pastor Joel is away November 19<sup>th</sup> through November 25<sup>th</sup> and he will make arrangements for a pastor to be on call for emergencies.

**Scholarship Mutual Funds:** Jim mentioned that these funds are down a little due to the market.

**Current Fund Money Market:** This fund shows a slight increase.

**Memorial Fund Money Market:** This fund shows a slight increase.

**Previous Year Comparison:** Jim reviewed this with Council.

**Memorial Fund:** Jim has shown all of the donations that have been made to the Memorial Fund. He has also shown the expenses that have been paid using the memorial fund donations. Jim reminded Council that if a specific designation for the money was made by a member then that money will be specifically used for the item they designated.

The Financial Report is filed for audit.

Penny reminded Council that the need to discuss the motion made by John Zimmerman at the September Congregational Meeting needs to take place.

Anneke expressed her desire to get together with Pastor Martini and Pastor Joel to determine how we go about calling to a part time pastoral position. That meeting will take place next week.

**Budget 2024:**

Jim discussed each line item of the budget for 2024 with Council.

Employee salaries were discussed afterwards.

Penny made a motion to accept the 2024 Budget as it is. Brad seconded the motion. A vote was taken. 6 yes votes were given.

At 8:25 pm Penny made a motion to adjourn the meeting and the motion was seconded by Steve. The meeting adjourned with The Lord's Prayer.

The next Council Meeting will be held on January 10, 2024 at 6:00 pm.

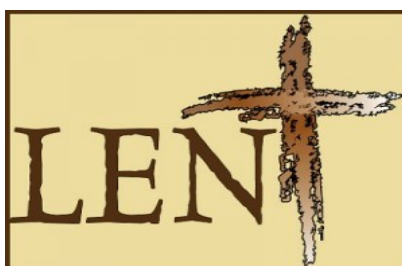
